If the information and documents requested by our Company in this application form are incomplete, we will contact you and request that you provide them to our Company as soon as possible. The application processing period will be suspended for 30 days until such information and documents are properly provided to our Company. In such cases, our Company reserves all legal rights.

Therefore, the relevant form must be sent in full and including the requested information and documents, depending on the nature of your request.

This application form has been prepared to identify your relationship with our Company and to fully identify your personal data processed by our Company, if any, so that we can respond to your application accurately and within the legally required timeframe.
